Please take the time to read and understand our Disclaimer. The following is the legal contact between You (Client) and ProfitDaily Group By making an investment with us you automatically state that you have read, fully understood, accept and agree to abide by our Disclaimer when using our services. Disclaimer defines ProfitDaily Group services including Client's and ProfitDaily Group obligations in regard to any transactions through ProfitDaily Group website.

1. General

1.1. Residents of any country can open an account at ProfitDaily Group .

1.2. Client invests Bitcoins into investment plan offered by ProfitDaily Group using 1 type of cryptocurrency.

1.3. ProfitDaily Group requires you to act as an individual and not on behalf of any other entity or authority.

2. Investment Plans

2.1. Client deposits money into one investment plan as follows:

Investment of 0.05 BTC up to No limits on our monthly investment plan with interest 20%

2.2. The minimum for depositing to the investment plan is 0.05 BTC and there is a No maximum limit

2.3. ProfitDaily Group can modify investment plan conditions any time.

3. Depositing Bitcoins

3.1. Depositing Bitcoins to ProfitDaily Group is executed with 1 type of cryptocurrency in accordance with this Agreement.

3.2. You must deposit Bitcoins only to the cryptocurrency address given on the Investment page. You can make as many deposits as you want to the addresses given on the Investment.

3.3. The deposit will be added to the list of investments after the transaction is confirmed by the network (3 confirmation is required).

4. Payouts

4.1. ProfitDaily Group investment plan earnings are paid out 24/7, 7 days a week (including holidays and other non-working days).

4.2. Unavailability of ProfitDaily Group website due to technical reasons, downtime, does not have affect on the payouts.

4.3. The payout usually takes around 10-15 minutes (automatic & instant). In some cases the payout could be delayed up to 12-24 hours, because we need to refill the hot wallet of the cryptocurrency.

4.4. The commission for cryptocurrency transfer is paid by us.
